Dear Ameet.

During last week, we checked the data related to TDS deduction of employees. There was some limitation in our checking due to non-availability of data. Also, we could not get proper replies on our findings also. Based on the limited checking, our points/observations are as follows:

- 1. We could not check the investment proof, as these were not provided to us completely of any employee despite of several follow-ups and reminders. Also, it seems that Investment proofs are not being checked by HR team properly for availing Tax benefits by the employees correctly.
- 2. In case of new employees, Salary and TDS of previous employer is not being considered, while calculating TDS from Semolina.
- 3. In one employee, we found discrepancy in Salary amount in Salary Register and Tax Register resulting into ambiguity in TDS amount.

• In Tuition fees employees have uploaded Coaching centre receipts which are not eligible for claiming 80C deduction but such amount has been used for calculating total deduction under section 80C.

Aside to above we have following observations also:

- In regard to employee Deepti Sadashiv Sheety (1004767) issues we are clear whether the salary of this employee is Rs. 4,33,085 as mentioned in the YTD sheet or Rs. 9,07,260 as mentioned in Semolina tax register yearly sheet. Once this is clear we can ascertain why there is short deduction of TDS of Rs. 19,429/-
- In regard to previous employers data of 81 employees we arrived at this understanding after discussion with Richa that this data was to be uploaded by employees on ZingHR portal at their own discretion. If the same was not done by employees they were not asked to provide the same.

- In Case of employee "Deepti Sadashiv Sheety" with Employee code "1004767" there is short deduction of TDS of Rs. 19,429 Employee resigned on 29th Sept'2023 & taxable income till DOL of Rs. 433085/- (New tax regime) as per income tax slab Tax is Zero, please check YTD register already shared to Ms. Richa
- Zing HR mentioned in one remark "NPS10PerBasic heads only display purpose, please don't include for deduction". Kindly confirm if the company has made any contribution u/s • 80CCD(2) or this amount is really just for display only. - "NPS10PerBasic" just for display only.
- Even Though employees have transferred from 1 legal entity to another still they are required to furnish Form 12B giving details of income from their prior employment to their current employer. Please update whether these forms were collected by the company or not. If they are then their details should have been updated in the Tax Register sheet and such amount should have been considered in tax collection. - Not required 12B because Employee code is same (If employee transferred from 1 legal entity to another not changed employee code)

Aside from that we also need investment proof scanned copies not the Compiled data in excel. Kindly share that. - Investment proof dump shared on OneDrive because file size is 70mb
