NON COMPREHENSIVE ANNUAL MAINTENANCE CONTRACT AGREEMENT

This agreement is executed at Mumbai on this 12th day of August 2021

This agreement is entered into between;

TECHNOCHILL INNOVATIONS PVT. LTD. ("Technochill"), having its office at 764, Bldg. No. 22, Gr. Floor, Opp. MTNL, Kopari Colony, Thane East, Thane - 400 603.

AND

MUMBAI AIRPORT SERVICES PVT LTD ("MALS"), having its office at 1st floor, Block A, Shivsagar Estate, Dr Annie Besant Road, Worli Point, Mumbai 400018.

WHEREAS, "MALS" wishes to appoint "Technochill" for providing service of Non Comprehensive AMC for the AHUs installed in the premises of various Lounges situated at & within Mumbai International Airport including deputations of Technicians in Regular shift for attending Break Down Calls & Preventive Maintenance, on the terms set out herein;

NOW THEREFORE, both the Parties have agreed as follows:

1) APPOINTMENT & EFFECTIVE DATE:

MALS hereby confirms the appointment of Technochill to provide service of Non Comprehensive AMC for the AHUs specified below as annexure (but services not limited to) in this Agreement to be maintained at & within premises of lounge, subject to the terms and conditions set forth in this agreement, and the Technochill accepts such appointment.

The effective date of this Agreement shall be **1st September 2021 or from the day full time technicians are deputed at lounges** (hereinafter referred to as "Effective Date"), for a period of 3 years from effective date.

2) CONTRACT TENURE:

This contract is valid for period of 36 months (3 years) from Start date or 1st September 2021, whichever is effective date as agreed by both parties.

MALS also reserve right to terminate or extend the contract any time with or without assigning reason.
