Contract Tenure:

This tenure is effective from 1st Oct 2022 to 30thSep 2025 for a period of Three year. We also reserve right to terminate or extend the contract any time with or without assigning reason.

SCOPE OF WORK

- Periodical servicing visits per year during the period of contract mentioned above.
- Attending unlimited breakdown calls in the event of a defect noticed on the fire suppression system upon the intimation in this regard by our technicians

Job Involved:

- Servicing/ Testing of Control Panel
- Inspection of Manual Call Point
- Inspection and / or replacement of blow off caps
- Inspection of nozzles and distribution piping
- Inspection of heat detection cable
- Inspection of Temperature Controller
- Inspection of Gas Shut Off Valve
- Resetting of the system.

Service report shall be provided on inspection of the system which will also indicate the replacement of parts required if any.

The products are covered in non-comprehensive AMC under the terms of the contract; the company is liable to replace the defective spare parts/consumable on a chargeable basis.

The Product should be made available for servicing as and when the service person calls on his periodical service visit with prior appointment. Failure to do so will be treated as service rendered and no refund shall accrue on this account.
