The humble petition on behalf of the Travel Food Services, Kolkata Pvt. Ltd. (company in short) most respectfully

#### SHEWETH:-

- That today i.e. on 27.03.2024, the instant matter is fixed before this Hon'ble Tribunal.
- 2. That by a petition dated 24.01.2023 it was brought to the notice of the Hon'ble Tribunal that by an Interim order dated 04.01.2023 passed in W.P.A. No.27211 of 2022, the Hon'ble High Court, Calcutta has been pleased to Inter-alia, restrain the 7<sup>th</sup> Industrial Tribunal from proceeding on the basis of the order of reference dated 24.06.2022 till disposal of the writ petition or until further order, which ever is earlier. Copy of the said dated 04.01.2023 was also submitted. Accordingly, this Hon'ble Tribunal was pleased to adjourn the matter.
