Thanks for your email.

As mentioned earlier, during integration we will put all the Govt. validations related to IRN generation at the time of invoice creation in Navision (except validating HSN number) as HSN data has to be rectified at item master level as one time activity. As HSN can't be verified before invoice creation due to multiple scenarios being applicable on HSN numbers.
