Contract Tenure:

This contract is effective from 01-12-2021 to 30-11-24 for period of 36 months. We also reserve right to terminate or extend the contract any time with or without assigning reason.

SCOPE OF COMPREHENSIVE RISK PROTECTION MAINTANENCE CONTRACT

- Unlimited breakdown Calls
- Any number of breakdown calls shall be attained during normal working hours under this contract.
- Resolution time same business day if the call is logged before 3 PM, else next business day.
- Saturday Breakdown call lodged after 3:00 PM will be attended on Monday.
- Breakdown calls lodged on Sunday /Holidays will be attended next working d a y

Place of Service

Travel Food Services Pvt Ltd. 1st floor, A Block, Shivsagar estate, Dr Annie Besant road, Worli Point, Mumbai 400018.

Normally the equipment shall be serviced at above customer's premises. If necessary the equipment shall be moved to our workshop for repair. The offsite expenses like transport packaging & insurance will be paid by the customers eparately.

Scope of work

- Attending all breakdown calls within normal working hours.
- Supplying electrical & mechanical spares like Compressor, Gas Charging, Electrical parts, Fan Motors contactors, overload relays,
- Quarterly p r e v e n t i v e maintenance i.e. 4 times in a Year.
- Two chemical washes for each Unit
- Free replacement of all spares (Only on receipt of defective spares) as and when required as result of normal wear & tear
- Free over hauling at site or at service station as and when required as a result of normal wear & tear.
- Comprehensive contract shall cover any repairing parts if required
- Checking the Equipments piping for signs of leaks and repairing the leaks, if any.
- Checking the machine, compressor and other drives for undue vibrations.
- Cleaning the air filters, evaporator coil, and finned surface of the condenser with air blower.
- Ensuring the condensate drain is not clogged.
- · Greasing of motor and blower bearings if required
- Checking tightness of all electrical connections and fuse links.
- Checking the operation of thermostat overload relays.
- Adjustment of air flow through ducts, if required.
- In case of compressor failure, the same will be repaired/replaced.
- If blower or condenser motor burns out, the same will be repaired by rewinding or replaced.

- The machines will not be shifted from the place of installation without prior intimation.

In no event we will be liable for any consequential losses whatsoever direct or indirect arising out of or damage caused by fire, rain, storm, theft etc.

Termination:

Either party may terminate the agreement at any time by giving one (1) month notice to the other party or the contractor shall refund the proportionate balance amount out of the total amount paid to them by TFS for the unexpired period out of the total period for which agreement is executed.

Notice:

All notice and other communication hereunder shall be in writing, except as herein specifically provided, and shall be emend to have been given when mailed by registered mail, to the intended recipient thereof at its address shownherein above or to such other address as the intended recipient may specify in a notice pursuant to this section.

Arbitration:

All disputes & differences arising out of connected with this contract failing a micable settlement will be referred to a mutually approved arbitrator, Mumbai.

Quality of Spares: The equipment parts replaced must be new and equivalent in performance of existing parts.

The Parties herein shall resolve all disputes in connection with this Contract amicably by mutual negotiation, failing which, the parties herein shall refer the dispute for arbitration in accordance with the Arbitration and Conciliation Act, 1996. The arbitration shall be referred to a sole arbitrator to be appointed mutually by both the Parties and failing agreement, as per the provisions of the Act. The venue of arbitration shall be Mumbai and the language of' arbitration shall be English. All costs and expenses (including the counsels' fees) in relation to such arbitration proceedings shall be borne by the Parties respectively.
