- sunroof mechanism remove and refit
- roof panel repair and painting
- roof lining remove and refit

Surveyor kept open for sunroof frame after dismantle he will visit to workshop and provide further assessment for the same. customer liability will be confirmed once the final assessment received from the surveyor . currently customer payable amount is Rs. 177338 including from bumper painting which is denied by Surveyor.
