a) Consolidate the orders and therefore, import as one shipment and possibly save cost on import. Attached is the workbook in which you can add your quantities and send back to us ASAP.

b) Use the consolidated orders to get quotations from a few CFA's, therefore, pick the most economical importer before

orders are placed with RAD.

c) We had done an import check and labelling information in June 2022 and bases your order quantities we will revisit the SKU's.
