Please find below the minutes of the meeting held at Dabolim Airport:

1. Existing Fire Line Checking (Sprinkler, Smoke Detector & Pipeline) - To be checked by the authority.
2. Water Line Inlet Connection - To be used exclusively for drinking purposes and not for sinks. (As per AAi officials)
3. HVAC Outdoor Unit Location & Duct Location - To be planned as required without utilising the existing ducts.
4. Existing HVAC Duct Insulation Damage Repair - (To be done by AAi officials)
5. Brand Specifications as per Airport Standards - (List to be provided by AAi)
6. Terrace Roof Waterproofing - (Work is ongoing)
7. Installation of Electricity and Water Meters - Confirmed as required.
8. Existing Main Electric Cable Size - (To be verified by AAi.)
9. Plumbing Drainage Existing Pipeline Location - As confirmed by the plumber.
10. Plumbing - CPVC pipes can be used.
