### **RULES REGARDING SELF STAY**

- when reservation is for self-stay than only Member, spouse member and dependent children up to 10 years can occupy the room. •
- Parties will be not allowed in the rooms. •
- Member has to check in personally along with Membership Card and guest are not allowed to Check –in on Behalf of member. •
- One Member/Membership Number can avail one room only on discounted rate. •
- Management has the full right to apply guest charges in the event of finding member not occupying the room at night. This will be supervised by the chamber staff on duty. •

#### **RULES REGARDING BOOKING OF THE ROOMS**

- 1. Charges will be as per tariff in force. Tariff if revised will be applicable to all advance bookings also from the date of reservation.
- 2. Not more than two rooms shall be allotted to a member. However, group booking with special permission from the management can be done depend on availability.
- Provisional booking will be made if no advance is received and shall remain valid only for 48 hours provided no other confirmed booking is received. 3.
- 4. No booking shall be deemed to be confirmed unless the same is confirmed in writing, by filling application form, total rental charges. Covering the full period of stay is paid by the person seeking accommodation.
- 5. Members/Guests are requested to carry a reservation confirmation letter, valid photo identity & advance receipt paid.
- Allotment of a room shall be for a period not exceeding 180 days at any one time. 6.

- 7. Request for extension extended stay shall be given in writing period can be considered subject to availability of rooms.
- 8. NSCI Delhi & Affiliated Members are requested to kindly send a scanned copy of ID along with accurate Check In/Check Out dates.
- 9. All dependent members will be allowed to stay in the room subject to written request by the primary member.
- 10. The resident members shall see that they and their guests are properly dressed while in the Club.
- 11. In the event or the occupying member's refusal or failure to vacate the room at the fixed day and time the Hon. Reg. Secretary or the person authorized by him shall be at liberty & shall have full authority to get the occupant out of the room with bag & baggage's & to take any further action as deemed fit in the interest of the club.
- 12. Resident members are entitled to receive visitors in their rooms from 7.00am to 12am on all days except during special occasions & functions as may be notified by Hon. Reg. Secretary
- 13. Visitors permitted in Room: Double Bed Room 4 persons at a time & Suite Room 6 visitors at a time.
- 14. Club or its management is not responsible for any valuables kept in the room. Guests are requested to use the lockers provided in the room.
- 15. Full day room charges will be applicable in event of the room not being vacated after 2 hrs. of registered Check out time.
- 16. The club shall not take any responsibility in the event of any members or their guest not being in stable mental state.
- 17. As management tries its utmost to ensure that various facilities and services in the Chamber room are in working condition, the Management will not be responsible for any breakdown, due to unforeseen factors.
- 18. Food snacks etc. provided in the room/Club are strictly against credit/debit or added to the room bill.
- 19. Cancellation is to be made in writing and in advance. The cancellation charges will be as per the rules laid down by the Club management. While booking the chamber room, the members/occupants are advised to ascertain the facilities normally available in the rooms and not raise such issue later on.

### 20. CANCELLATION CHARGES FOR MEMEBRS/GUESTS

- A) When intimation for cancellation is recd. between 00Hrs to 12Hrs from the time of check in 100% Cancellation Charges
- When intimation for cancellation is recd. B) Between 12Hrs to 72Hrs from time of check in 50% Cancellation Charges
- When intimation for cancellation is recd. between C) 72Hrs to 168Hrs from time of check in 20% Cancellation Charges When intimation for cancellation is recd. before 168hrs. 10% Cancellation Charges D)

No Cancellation will be allowed after check-in. The Secretary is empowered to cancel any booking, in emergency of reserved accommodation giving 24 hrs. Notice to the concerned member. On cancellation by the Management the member will be entitled to full Refund of amount paid by him/her.

- 21. The check-in time is 12.00 noon & Check out time is 11.00am.
- 22. Refund should be taken within 30 days of settlement of chamber bill.
- 23. Request for extension of period can be considered provided the same room is not booked for another person or if any other room is available.
- 24. In case of cancellation within 48 hours of occupation at least one day charge will be recovered. No refund is payable for the day of cancellation unless the room or rooms booked are occupied by others for the same day.
- 25. The room/waiter services are available in the chamber during the following hours.

- 26. In case of date change, cancellation charges as per policy shall be applicable by submitting a letter.
- 27. Affiliated Members are not allowed to book a room for guest.
- 28. Affiliated Member can book not more than one room for Self/Family.
- 29.A Members can avail self-stay discount of 50% maximum up to 45 days a year.
- 30.Reciprocal letter is mandatory from affiliated members.
- 31. For room reservation first preference will be given to members and then their Guests.
- 32. Stay of alone lady/dependent lady members will be allowed subject to written request by the member minimum 3 days in advance of checking in date.
- 33.No get together or functions will be permitted in the room. No service will be provided.
- 34.. No lady visitors are allowed in single gents occupied room, unless verified and permitted by the Management.
- 35. No Male visitors are allowed in single lady occupied room, unless verified and permitted by the Management.
- 36. No unmarried couples are allowed to stay in the rooms.
- 37. All outstanding dues will be transferred to the member's account unless it is settled at the time of Check-out.
