Earlier, it was proposed to finalize design for Irish House at T1 Forecourt in approx. 200 Sqm area. Later on, Beer Garden was finalized instead of Irish House. Several bidders have initially submitted quotation for consultancy of Irish House. Considering urgency to finalize consultant for this work, all the bidders were instructed to submit their commercial offers on urgent basis. After initial offers submitted by interested bidders, ARA design was L1 for this requirement. During negotiations, they agreed to reduce their prices and submitted their final offer which is **Rs.**1.95 Lacs lesser than their offer submitted for consultancy of Irish House.
