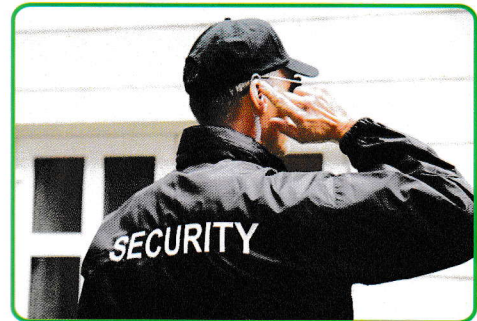
- **HOUSEKEEPING SERVICES**

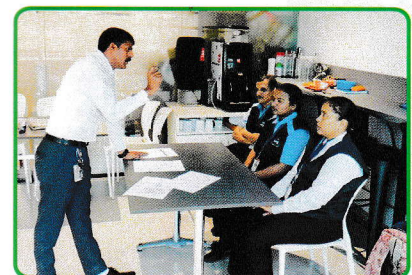

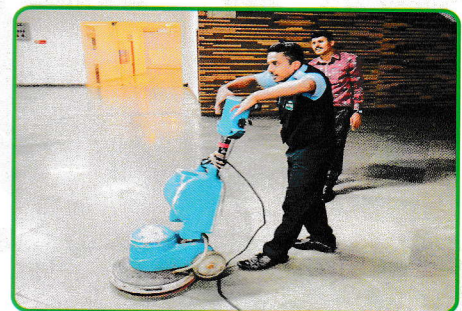
