It does not provide protection against oil, strong food particles, dirty finger marks, pen or ink stains, pet damage, etching and/or acidic substances.
- 7. NanoTek Solutions shall not be responsible for (i) existing stains/marks and/or (ii) stains/marks that come from beneath/inside the surface being coated.
- 8.The Firmlok Coat is only a precautionary coating, and the client needs to ensure general safety and precautionary measures while using wet and slippery surfaces as there are various reasons for accidental slippage.
