Please find below comments by Asset team on the renders of Nourish, Idli.com and Dhaba

They are ok with the render of Nourish but please incorporate the comment in Idli and Dhaba

1. Brands to avoid puncturing the interdemise partitions. Any cladding/ panelling has to be supported by separate framework which should be anchored into the Ceiling and Floor Slabs **Yes we have already do this in our Interior docket.. please see the drawing details once.**
2. All exit doors (including Flap doors) need to be min 900mm clear and should open in the direction of egress.
3. Some elevations may need to be redone as per the comments in the attached doc. **Old views please share the final views with airport for final comments**
