


PROJECT UNDERSTANDING

The services to be rendered by FINCH shall be those described in this contract. Professional services for the purpose of this agreement will be professional services commonly expected of an Interior Design Practice.

CLIENTS ROLE

The client is expected to provide FINCH with all the necessary documents required so as we can provide our professional services. Including but not limited to CAD drawings of the project from which we are to work from, access to site to carry out surveys and site visits, landlord and or tenant coordinator details and any other reasonably required documents, this will be at no cost to FINCH. In order to keep on schedule and to the timeline the client is expected to respond to correspondences from FINCH within a 48 Hour time period within the working week (Monday to Friday), this may be by email, or phone or in person.

COMPENSATION

The financial compensation for services rendered by FINCH mentioned in this proposal and agreement are for what we deem to be expected of us as Interior Design Consultants for this project based on the initial brief we received. Further demands of our professional services that are not included in the scope of works such as extra visuals, design variations will be charged at an extra rate to be agreed in advance by the client.

PAYMENTS

Payments will be made directly by bank transfer into the Emmas Design LLC company account detailed below or by company cheque addressed to Emmas Design LLC.. Payments will be as per payment schedule mentioned earlier in this document. Payment terms will be unless stated otherwise within 7 days of receipt of invoice from Emmas Design LLC. FINCH reserve the right to hold onto all drawing packages and concept visuals produced for the client and project as well as cease to commence any further work in any instances where they have not received payment as laid out in the Payment Terms section of this agreement from the client. Payments are non refundable.

GENERAL TERMS

ACCEPTANCE AND REVIEW

The Agreement may be accepted only by signing a copy of this document and returning the same to FINCH by acceptance in such manner, the Client agrees that both parties are to be bound by the terms and conditions embodied herein which shall constitute the entire agreement. This contract supersedes any previous agreements and is subject to renegotiation if acceptance is not completed within 30 days.

TIMINGS

All timings are estimates and are based on calendar working days of the UAE. For FINCH working days are from Monday to Friday 9:00 am to 6:00 PM.

TERMINATION

If either party fails substantially to perform in accordance with its terms, this Agreement may be terminated by the other party upon a 30 days written notice. Where a breach



is remediable and the party in breach has not remedied the breach within 30 days of receiving notice, the Agreement may be terminated forthwith (without prejudice to other remedies). If Emmas Design LLC goes into receivership/liquidation or if there is a change in ownership/control, the Client has the right to terminate this Agreement. If the client's building is damaged other than superficially by fire or any other cause, the client has the right to terminate this agreement. In the event of such termination full payment shall be made for such services performed to termination date including reimbursable expenses when due.

Any changes in the project specifications desired by the client shall be promptly communicated to FINCH. Any changes to previously approved work requiring additional services will be subject to



additional fee billing in accordance with our daily fees mentioned in this agreement. All changes to previously agreed and approved designs must be authorised in writing by such authorised representative as the Client may designate. For concept design this fee proposal covers a maximum of 2 variations from the first presented concept design. All other changes and variations after the second amendment will be charged at an extra pro rata cost based on time. These are currently charged at 2,500 AED per day for the lead designer. After the concept is approved and signed off all other changes thereafter will be subject to an extra charge.

ADDITIONS

Any additional design or other services requested by the Client outside of the scope will be subject to a variation fee and need to be approved firstly by FINCH. FINCH reserve the right to reject any additional work.

THIRD PARTY CONSULTANTS

The employment of any specialist third party consultants including but not limited to MEP Consultants, Lighting Designers and Fit Out Contractors shall be subject to prior notification and client written approval. FINCH is not liable for damages incurred by third party consultants.

OWNERSHIP

All project designs, renderings and drawings developed by FINCH and approved by the Client under this agreement shall become the property of the client upon the receipt of full payment to FINCH for the full project value.

FINCH shall retain copyright on all unique FINCH designs and release of copyright ownership will be subject to a separate financial agreement which equates to double the value of this contract. FINCH retains all concept and design rights for any design awards for the project. FINCH to be credited as the lead designer in any press, promotions or awards.

ESTIMATES

FINCH has no control over constructions, fabrications, furnishings or printing costs; any estimate of cost for the project which may be made by FINCH pursuant to the services provided for herein will be made on the basis of its experience and qualifications and represent the best judgement of design professionals. However FINCH cannot and does not guarantee that proposals, bids or the actual project cost will not vary from any of its prepared cost estimates. Excluding our professional services fee for interior design services as mentioned in paragraph 2 of this agreement. This will not fluctuate based on the original agreed scope of works, should that scope of works change it may be subject to an extra fee as mentioned in paragraph 3 of this agreement.

DRAWINGS

Contractor will need to provide shop drawings to be reviewed by FINCH prior to commencing site works. FINCH's Detailed Design and Tender package drawings are not full construction drawings.

DELAYS

Performance of the services by FINCH by shall be pursued with due diligence in all requirements hereof, however, FINCH shall not be liable for any loss or damage for delay or non-performance due to causes not reasonably within its control. In the event of any delay resulting from such causes, the time for performance hereunder shall be extended for a period of time reasonably

necessary to overcome the effect of such delays. In the event of any delay or non-performance caused by such uncontrollable forces, FINCH shall promptly notify the Client in writing of the nature, cause, date of commencement thereof and the anticipated that the completion dates or fees will be affected thereby.

SETTLEMENT OF DISPUTES

The parties shall make all reasonable endeavours to settle amicably any dispute connected with the formation, performance, interpretation, nullification, termination or invalidation of this agreement or arising there from or related thereto. Any dispute which cannot be amicably settled between the parties within twenty eight (28) days after the dispute arising may be referred by either party to conciliation in accordance with the provisions set forth in the Rules of Commercial Conciliation and Arbitration of the DIFC Courts.

ENTIRE AGREEMENT

This Agreement by Emmas Design LLC herein represents the entire understanding and agreement between the parties hereto relating to the services and supersedes any and all prior agreements, whether written or oral, that may exist between parties regarding the same. To the extent that any additional or different terms or conditions whether contained in the Client's purchase order or any other document conflict with the terms and conditions of the Agreement, the terms and conditions of this Agreement shall govern. No amendment or modification to this Agreement or any waiver of any provisions hereof shall be effective unless in writing and signed by both parties.

LAW TO APPLY

The validity, interpretation and performance of the Agreement shall be governed by and construed in accordance with the laws of UAE enforced by The DIFC Courts.
