Dear Sir,

Following are our observation for additional work related to HVAC system.

- AHU - We have changed the size of AHU from horizontal to vertical due to constraint of AHU room. The proposed horizontal AHU dimension was not fitting in the required room size. Hence, we had asked them to change to vertical.
- VRF ODU - We believe that VRF ODU should be supplied as top-discharge (default) as the same systems was used in Phase-1 also.. Anjle MEP was the HVAC vendor who also executed Phase-1, then how did they quote for side discharge? They did not visit the site before bidding and wrongly quoted side discharge ODU. We also believe that 34 HP cannot come in side discharge as a single module. This reason for additional cost is not acceptable.
