- Application for this BOQ/commercial offer will be carried out part/floor wise for seamless execution.
- Any external disturbances caused on-site during the work which may lead to delay in completion of the project will not be Primus Enterprises responsibility & will lead to extension of work completion duration.
- For exact area calculation, our part time engineer/architect will visit the application site within the first week of work commencement.
- Approval from your organization is required over the "final area calculation sheet" submitted by us within 3-4 working days, which will be used as reference for calculation & billing.
- Final bills will be raised as per the actual area covered under application.
- Any ad hoc requirements will be billed as actual to your organization.
- **Payments Terms (Inclusive of taxes): -**
- **For Material Supply (Incl. of GST) :**
 - 100% payment to be processed as advance amount for the material procurement at the time of purchase order releasing - (Rs. /-).
 - Post 100% payment clearance against material delivered, application work by labor will commence on- site.
 - **For Labor Application Charges (Incl. of GST) :**
 - 20% of the labor charges to be paid for mobilization – (Rs. /-).
 - Remaining 80% of the labor payment for application to be cleared on "running bill" basis for part/floor wise within 4-5 days from the running bill submission date.
 - Failure to meet the payment terms will allow Primus Enterprises to halt the ongoing application until the payments are fully cleared. Intimation of operational halt will be done 24 hrs. prior.
 - At any point of time if scaffolding is required for the project the charges will be extra.
 - All the supporting documents like Product Certificate, Work Completion Certificate, Warranty Certificate (if any) will be furnished & submitted to your organization post receiving of all the payments as per BOQ.
 - Agreement and orders cannot be canceled/modified by buyer under any circumstances without buyer first reaching an agreement in writing with seller covering all damages. If cancellation/modification is agreed by the seller, then the buyer has to promptly pay all the reasonable engineering & other expenses incurred by the seller in connection with this agreement. In either case 20% of the agreed price has to be paid as settlement in case of cancellation.

 - Any physical damages to the coating caused after completion or area handover will be identified as patch points. A separate quote for patch repair of patch points will be submitted for payment clearance.
