Reference Circular No. MFS/2015/10/1462 dt. 16 Sept 2015 from the office of the Fire Advisor, Shri MV Deshmukh, Govt. of Maharashtra – audits are to be undertaken in the months of January & July every year through the licensed agency; the same is attached towards ready reference please.
