The approach taken for the bifurcation of the outlets is as under:

- Time being of essence, the attempt has been to divide the area equally amongst both the designers so that no one is overburdened and timelines are met.
- Divide the number of outlets between the 2 shortlisted designers within an airport to ensure work gets done faster and contingency plan (not putting all eggs in 1 basket)
 - Overall M/s Genesis gets ~54% outlets with 25.5% area for designing.
 - o M/s Ara gets 16% of the outlets with 26.8% of the area for designing.
- International QSR brands would do designing of the outlets on their own.
- We are proposing to appoint ABM for the designing on the Transit Hotel in Lucknow
- Chapman & Taylor is already working on the lounge designs in these airports.
- Fellow Design has designed the food trucks for MUM T1Arrival forecourt, and they can be given to do the same for the Ahmedabad Food court as well. That design is more cuisine specific.
- Ahmedabad T2 lounge extension design will be done in house by the semolina team.

Would request all of you to go through the attached file in detail and share concerns, if any on the approach, or else we will go ahead with the release of PO to the respective vendors to kick start the work.
