This mail is regarding the ongoing project CIP Lounge at terminal 2-Jaipur Airport, We wanted to express our concerns with an update on the progress of CIP Lounge, Jaipur Airport project, and discuss some critical issues that have been affecting our timeline.

Over the past month, we have been facing several challenges that have significantly hampered our progress. The key issues we are currently dealing with include:

Pending Available Fronts: We have encountered delays due to certain areas not being accessible or ready for work as planned. This has affected our ability to move forward efficiently. We are still in a dismantling phase due to pending decisions for the fronts like existing ducting dismantling, IT rack cable, wires to be raised to a defined ceiling height, bay side block work till ceiling height due to existing duct concurrence.

Latest Drawing Revisions: We received the latest revisions of the project GFC drawings on October 5th, 2023 (90%). These continuous revisions in drawings make our team sit idle as we are not able to procure items and make fronts ready to our teams as per the submitted schedule moreover we had deputed the teams on 1st September 2023 to ensure that we will align them as per the project's requirements but still we are not able to do so due to above-mentioned reasons.

Existing Duct Dismantling: The dismantling of existing ductwork through the passage is still pending. This needs to be done through M/S Adani's specialized HVAC Team due to space constraints but it has been more time-consuming than initially anticipated, adding to our project timeline.

Airport Passes Availability: We have been facing challenges in obtaining the necessary airport passes and clearances for our team members as we are not able to anticipate when and how to align teams for the work further.

Idle Manpower: As all the staff and manpower have been deputed from 1st September 2023, we are still covering the dismantling phase of the project which needs to be finished on 07th September 2023 as per schedule. This idle period has resulted from factors beyond our control, primarily related to the delayed availability of work areas on the project site. As a result, our dedicated team has been unable to carry out the planned tasks, causing a considerable setback to our project deliveries. We now submitting the idle manpower cost sheet for review and further approvals for the month of September 2023.

We understand the importance of adhering to project timelines and ensuring that the project progresses smoothly. The manpower and resources allocated to this project have been diligently prepared to meet the requirements, and we are committed to delivering the project, we will submit the revised schedule once all the above-mentioned points are clear.

Given these challenges, we are currently falling behind schedule, and it is essential that we address these issues promptly to ensure the project's successful completion. Please let us know your thoughts, suggestions, or any additional information you may require from us to make an informed decision. We appreciate your understanding and collaboration during this critical phase of the project.
