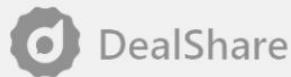

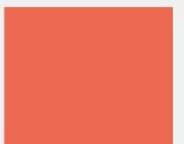
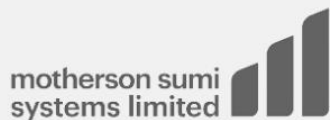

## Features and Details of the functionalities

### System Settings

#### Configuration of the system

- Define applications settings like locations, categories, vendors, status, etc.
- Add company logo at the login page and inside the app.

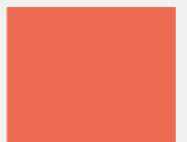

  - Cost of Parts used in Repairs
- Reminders & alerts for activities through mails

## Incident Management/Work Orders/Helpdesk

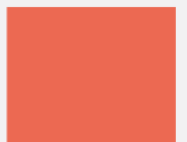
- Ticket for reporting faults, breakdowns or complaints

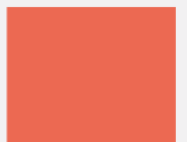

# Data Security

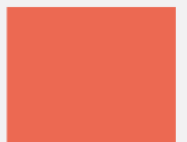
## Security

1. Application is hosted on Microsoft Azure SaaS in their West Europe region.
2. Each organization's data is maintained on separate databases – to enhance performance and security
3. Data in-transmit is encrypted using SSL/TLS certificates
4. Data at rest is encrypted using Transparent Data Encryption on SQL Azure Databases
5. Web Access Firewall (WAF) is used to protect any unwanted intrusions

## Backups and Disaster Recovery

1. Real-time backups with geo-replication services for all data
2. Disaster Recovery Site is automatically switched on with no down-time in case of a disaster

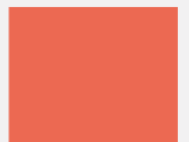
