# FACILITIES TO BE PROVIDED BY THE CUSTOMER AT SITE OF WORKS

Items of work listed below are not included in Blue Star's scope of work & quoted prices and those facilities are to be provided by the Customer at the site of works.

- 1) Provision of Stabilized Power Supply for all units within 0.5 meter radius of Refrigeration unit with suitable Metal clad plug socket, MCB, etc
- 2) 0-0 leveled floor to be provided
- 3) MS stands for Condensing units to be supplied by Customer.
- 4) Provision of condensate drain traps and related plumbing works at points to be nominated by us.
- 5) Provision of Stabilized Voltage Supply and Electrical control Panels distribution boards, Single-Phase preventors, etc. if required.
- 6) Provision of any civil work, masonry work, steel structure/truss works for supporting the wall and ceiling panels, racks, lighting, concreting, material handling etc to be arranged by the Customer.
- 7) Provision of suitable shields, platforms, stands for condensing/evaporator units, scuff-holdings & protection from sunlight, Rain etc.

- 8) You will provide anything not mentioned specifically in our offer
- 9) Unloading of the material at site will be under customer scope.

10) We reiterate that any other civil / electrical / plumbing works / Accessories etc which forms a requirement at the site of works are specifically excluded from our scope of work.

#### ANNEXURE V- CONDITION OF CONTRACT

- **1.VALIDITY:** Our offer is open for acceptance for a period of 30 days from the date of this offer. Thereafter, it shall be subject to our written confirmation.
- **2.SPECIFICATIONS:** In line of our policy of continual improvement, we reserve the right to modify the design and change the specification of any material, if in our opinion, such modifications constitute an improvement or is in accordance with revised standards of mfr. methods. Therefore specifications, illustrations, dimensions and weights given or agreed to by us in our proposal, catalogues, drawings photographs etc. are not binding in detail.
- **3.EXCISE/ CUSTOM DUTY:** Rupee Price quoted are inclusive of EXCISE DUTY / CUSTOM DUTY at currently prevalent rates on fixed assessable values. Any variation in the rate of E D./ C.D. or any change in the method of computation of E.D./ C.D. until delivery will be to your account.
- **4.SALES TAX:** Local Sales Tax excluded and will be charged as applicable at the time of execution of the order. Any exemption or concessional rates of Local/Central Sales Tax will be subject to eligibility of the customer and furnishing of necessary declaration/certificate/C or D in the prescribed forms.

Our offer does not include any Octroi / Toll / Cess / Entry or similar tax. The same will be payable by you directly to the authorities.

**5.PRICES**: The price quoted is in Rupees.

6.**DELIVERY PERIOD**: 5 to 6 Weeks from the receipt of your technically & commercially clear order, drawing approval and advance. Further 7 to 10 days for Installation & Commissioning subject to site readiness..

7.PAYMENT TERMS: As above

**8.WARRANTY:** Subject to terms of payment agreed upon being punctually complied with and the equipment being operated properly, the machinery covered by this contract carries a Warranty against manufacturing defects for 15 months from the date of supply or 12 months from the date of installation, whichever is earlier. If any part of the equipment is put to use earlier for any reason, whatsoever, the warranty period will commence from the date of such use.

We agree to repair/replace such parts which may prove defective and which do not fail from neglect or misuse or faulty operation.

The defective parts must be sent to us, duly insured and freight prepaid for examination and our agreement that they are defective. The return freight and insurance charges on such repaired or replaced parts will be born by the customer. No charge will be made by us for work involved in the repair or replacement of defective parts during the Warranty period in the case of installations within the Municipal limits of any city where we have our own Branch or Service Centre.

Should, however, the services of our qualified men be required outside these limits our standard charges for such services will apply.

## This Warranty:

- I) does not extend to consequential damage or loss;
- ii) is null and void if repairs and modifications are carried out without our approval in writing;
- iii) does not cover damage due to normal wear and tear;
- iv) does not cover due to deterioration or failure of equipment, controls, due to corrosive atmosphere;
- v) does not cover supply of consumable items like refrigerant, oil, etc.;
- vi) does not cover damage due to fluctuation in voltage.
- **9.LIMITATIONS TO LIABILITY:** In no event shall we liable for any consequential damage arising out of or connected with this contract in any way whatsoever.
- **10.PROPERTY RIGHTS AND GENERAL LIEN:** As unpaid vendors we shall retain the property rights in the equipment and material supplied by us under this contract, and our rights of lien and resale, until full value thereof as per our bill is paid to us. We shall also be entitled to a general lien on our equipment and materials in the customers possession under the contract for monies for the time being due to us from the customer, on any account and shall be entitled to apply payment already received to monies due to us under any other order or orders.
- 11. CANCELLATION CHARGES: If any order or part of order is cancelled, the cancellation charges levied by Blue Star Ltd. / BSL's Principal shall be borne by the customer. In addition, the customer will pay BSL Compensation for cost and expenses incurred by BSL upto the date of cancellation.
- **12.FORCE MAJEURE :** No liability shall attach to us for non-performance or delayed execution of this contract as a result of force majeure.
- **13. Arbitration**: In case of any dispute or difference arising out of this contract the same shall be referred to Arbitration by a panel of three Arbitrators, one each to be appointed by either party and the third by the two Arbitrators so appointed. The provisions of the Indian Arbitration and Conciliation Act, 1996 shall apply to such Arbitration. The Arbitration proceedings will be held in Pune

- **14. Jurisdiction :-** This agreement shall be subject to the exclusive jurisdiction of the Courts in the City of Pune

or installation, commissioning as a whole or part thereof subsequent the date of quotation and up to the time of final billing, in the event of such statutory variation, the BSL shall levy the tax accordingly"
