- Issuing tender documents with the bill of quantities giving a detailed technical specification of MEP services, equipment, and makes/models. Annexure-1: Terms and Conditions

1. <u>Basis of design</u>: Operators' basic design guidelines will be followed by us to draw the layout. However, the layout and plan will be based on area allocation required for each section of the kitchen and workflow plan related to the same. The final decision will be mutually agreed upon with the operation team. Any additional areas to be planned in the future which are not included in our present scope of work will be charged extra.

2. Rework:

- Kitchen Consultant: If tender documents are approved once and need to be revisited due to the changes in concepts or budgetary constraints or due to force majeure, it will be charged @ 75% of the contract value.
- 3. <u>Outstation projects</u>: If any project is outside Delhi NCR, all outstation charges applicable be it by air, road conveyance, hotel boarding lodging, and all incidental expenses will be fully arranged by you for the entire team members of our company who may be deputed at various stages for implementation of the project.
- 4. <u>Delay/termination</u>: In case of a hold of project or delay of project or termination of agreement bills raised till the date of such eventuality will be paid in full without any delay.
- 5. <u>Taxes & deductions:</u> all payments shall be made inclusive of Goods service tax @ 18% (borne by the client) and after standard income tax reductions (borne by us).
- 6. <u>Time Duration</u>: The project completion time anticipated is 3 months with 3 visits to the site. Any overrun of the project -post which PRO-RATA payment will be applicable.
