Regarding the Bill of Quantities (BOQ) related to the basic civil work. As outlined, the BOQ includes the following components: Block Wall Work, Plaster Work, Floor Filling, Waterproofing, Dry Wall Paneling, Ceiling Paint, Putty Work, and all civil and plumbing work of the back-of-house (BOH).
