This warranty covers only the manufacturing defects of equipment or parts and will EXCLUDE consumables and wear parts such as glass and plastic parts, blades, gaskets, rubber parts, bulbs, heaters, seals, brushes, pads, filters, wheels etc., and all wear and tear components/parts.

The warranty will be null and void if (a) Equipment or component is damaged due to voltage fluctuation. (b) Equipment is mishandled, misused or overused beyond capacity. (c) If machines designed for intermittent use are operated continuously.

This warranty includes only free replacement of defective parts, repairs to metal body by our technicians and free labour. But does not include traveling, local conveyance, lodging and boarding expenses of our technicians.

The warranty will be null and void if equipment is either installed or repaired by unauthorized person/s.

#### Other Terms & Conditions:

1. Any changes in model or configuration shall be informed us prior to One-month notice
2. Any changes in prices for any reason shall be informed us prior to One month written notice
3. The above rates shall be applicable to Travel Food Services and its affiliate companies
