MOM of CC Bandra Meeting as on Date 12-Mar-24.

Meeting Attendee's: Mr. Amarpal Gandhi, Mr. Matin(BMC) with his Junior Engg. Mr. Kharkar (BMC), Mr Amey. Mr. Amol. Mr. Ravi.

Discussed Point mention below.

- 1)They won't be able to let us remove entire middle wall.
- 2) They are allowing us to remove only 3 walls between the column from the entire middle wall. Which is the center part of the entire middle wall. Please find the attached file for your reference.
- 3)According to the BMC people we are not able to break the Kitchen wall , but as per MR. Amarpal Gandhi , we can remove the wall and do the needful changes according to us but after consulting with the structural engineer.
- 4) Proposed fire exit door location is denied by Mr. Amarpal Gandhi, he said that we have to use exiting fire exit door only.
- 5)Near the existing fire exit door & exiting toilet there is a enteral partition wall is there , we need to remove this wall & connect this passage to our proposed toilet. For this Mr. Amarpal Gandhi will check with the BMC guy and come back to us with answer in 3 to 4 days.
- 6) Apart from the 3 wall that BMC has given permission to break or remove ,Mr. Amey has asked for an opening in the wall which is near the entrance of the outlet. Here in the wall, which is between the two columns , we need to remove the half part of the completely & in other half part we will make half height wall and put some glass & railing there. So that we can make there is visibility and a place to go in the adjacent part for the guest. And they also said that if we can't get this ,then we won't be able to open this place. Please find the attached image for your reference. On this issue, Mr. Amarpal Gandhi said that I will check it back from the bomb in 3 to 4 days and let you know.

The following are a few critical points.

- Half of the kitchen area and the banquet area have been extended with the help of girder and slab on Cota tiles, which may leak during rainy seasons. There is a need to waterproof the entire area.
- There is a 9-ft ceiling height in the restaurant area, which will again pose an issue for the installation of ducts or for the operation of air conditioning.
- There is no separate stairway to access the services.
- Multiple areas of seepage have been observed in the banquet.
- It is necessary to check the structural strength and to obtain a stability certificate.
