The agreement with the Merlot lounge at T1 terminal with the current concessionaire has expired and they have vacated the space. We intend to take-over the space to operate as a lounge in the domestic terminal with tie-ups with cards and walk-ins. The space will also sell liquor. This outlet takeover is also as per our AOP. The key points are as under:

- The avg. sales from this location was 30 lacs a month including liquor sales. We have built the business case basis that only.
- I have negotiated a lumpsum amount of 5 lacs with the outgoing concessionaire for the furniture and other equipment which was
 of our interest. (list attached)
- We will have to do a refurbishment of the space which will include change of flooring, creating a buffet counter, general painting & repairs of the existing furniture/structure etc. The estimate of this work is around 15 lacs. (estimate attached). I don't suggest that we go for a complete refurb at this stage and can look at the same after 15-18 months if required.
