- 2. Factory visit with team of technical persons and colleting necessary details pertaining to onsite plan and risk assessment report.
- preparation of draft Onsite Emergency Plan and Risk assessment report using EPA approved DNV
 SAFETI software (which was approved by MOEF and EPA).
- 4. Preparation of Onsite emergency plan as per MSIHC Rules 1989, Sch.11.
- 5. Identification of Risk levels and damage distances due to thermal radiation due to fire and shock wave pressure due to explosion and preparation of Quantitative Risk Assessment report as per the guidelines.

- 6. Providing necessary Recommendations for the risk reduction measures and convert to Acceptable levels.
- 7. Damage distances are incorporated in the A cad drawing of site plan for Thermal radiation distances in three levels and vapor cloud explosions in three levels.
