Please be informed that, to finalize suitable vendor for Lucknow Street on time, we had proactively called a joint meeting to identify the vendors who shall be considered for tendering process.

However, though TC team suggested to consider Impulse and Pioneer at that stage, it was informed that they are already been occupied with other projects and it's better not to consider them to avoid interruptions in CIP lounge and AJ Kitchen. At that point of time, it was decided to engage either new vendors or existing vendors like Fallow Dezience (FDT) and VSAS who had already completed their projects.

Whereas, in our last discussion, you have recommended to include Impulse and Pioneer since FDT was L4 and though they are BCAS cleared, you informed that they are already been occupied in Ahmedabad's Non Aero projects hence not advisable to proceed with them and based on experience with VSAS, team was not confident to award them this project and L2/L3 vendors were new vendors which were also ruled out. Hence, we issued additional enquiries and negotiated them to bring down the cost which had consumed additional 6 days to reach at this stage.
