Dear Sir,

I kindly request you to review the table below, which outlines the daily production versus the capacity of the Blast Chiller.

Currently, the Blast Chiller has an average cooling capacity of 120 GN Pans per day (10 GN Pans per 120 Minutes), whereas the production rate is 291 GN Pans per day. This results in a shortfall of cooling capacity for an additional 171 GN Pans daily, making it difficult to manage the required cooling time for all GN Pans.

Due to this shortfall, and considering the cooling cycle (90 minutes for cooling and 30 minutes of resting per load), the production team is unable to allocate the required 30 minutes of resting time. This has led to additional strain on the Blast Chiller, resulting in frequent maintenance issues and breakdown challenges.

I would kindly request you to refer to the attached details, along with several prior email communications, as references to the recurring breakdowns of the Blast Chiller (since 2019).

Dear Sir,

Please find the blast chiller requirement causes.

Note:-

- 1. Our existing Blast chiller has a cooling capacity of 10 No. 6 inches GN at a time and takes 90 minutes. According to the maintenance protocol, once the food is cooled, the machine has to rest for 30 minutes.
- 2. Since we have only one blast chiller, we are not able to cool all the food as per our consumption. Hence, we are forced to keep the food outside to cool it, which will later cause us quality issues. Hence, we request that if you keep all these things in mind and provide us with another blast chiller, we will be able to make our production smoothly and without any quality issues & spoilage.
