Dear Abdhul Rehaman,

When we sent out commercials, we were not aware of your LD clause. These are not in line with the general LD clause followed.

As per our understanding, the LD clause has a penalty of 1% per week, with a maximum of 5%. We have already committed to very tight deadlines that too under restricted working conditions, which only include late evening and night working hours for 6 days of the week, and have also worked on tight margins.

Had we been made aware about your stricter LD clause we would have added 10-days to our deadline. Considering the current LD clause, we request either an extension of the deadline by 10 days or an adjustment to 1% LD for the first week and 2% for the subsequent weeks. Beyond this, we will not be able to accept the terms.

Please also note that total kitchen equipment, exhaust chimney, drain out let connectivity and SS racks are not in our scope and we can take up ownership delays in those items as we have to coordinate this also in our handing over deadline.
