 - For imported/branded equipment price may vary subject to currency rates variation (Dollar/Euro) or price escalation by Principal company.

 - Production will be started only after the confirmation of the order is received, which includes Purchase order, Signed Proforma invoice, Advance payment & drawing approval in case of custom fabrication.
 - Once order is placed, it cannot be cancelled. If that happens the payment deposited will be forfeited with company to recover cost of the fabricated equipment already manufactured as per the client specification.
 - Delivery, Unloading, installation, wooden packing/sea worthy packing/fumigation or any other charges not mentioned in quote will be extra at actual.


DISPATCH & DELIVERY TERMS:



- Dispatch will be processed only after the receipt of balance payment with GST & other additional charges as mentioned in quotation.
- Upon receipt of balance payment, 3-4 working days will be required for dispatch of ready material.
- Goods damaged or theft during transit is not our responsibility, our responsibility ceases once our goods are dispatched from our premises.
- While unloading of material, if possible, our engineer will be present there for guiding safe unloading of equipment to site.
- Safe storage of material will be solely client's responsibility. Products/parts damaged on site by others will not be covered in warranty and will be on chargeable basis if repairing required.
- Internal shifting of equipment from safe storage to actual site location will be in client scope.

INSTALLATION:

CUSTOM FABRICATED/ELECTRICAL EQUIPMENT

- Customer will have to arrange to provide necessary Electricity, Gas, Water & Drainage/ Plumbing connections required for Installation.
- For installation of equipment, hardware fitting or electrical wiring connection to equipment will be in client scope.
- Hardware & electrical fitting refers to: Taps/ Faucet, Water or Drain Pipes, MCB Switches, Wiring, Plugs, Water Softener.
- Gas Connection from PNG Line to Equipment will be in client scope. Connection hose pipes will be charged extra.
- In Case of Tandoor Fitting on Site, Fitting Charge on site will be charged extra at actual. Sand will be supplied by client.
- In Electrical equipment standard wire length will be 2.5 meters.

IMPORTED / BOUGHT OUT EQUIPMENT



- Any such equipment required installation; company executive will come only 1 time for installation.
- Second visit of such technician will be chargeable. Please make sure site is ready for installation.
- For equipment such as Ice Cube, 2-4 bar pressure RO Water is mandatory.
- Dish Washer Machines & Combi Ovens 2-4 bar pressure of 70-150ppm water is mandatory.

DRAIN TROUGH



- Only supply of Drain trough will be in our scope, installation & connection will be purely in client's scope (Plumbing/Civil contractor).
 - We provide drain pipe of 75 mm standard height, which can be vary as per the client's requirement, but this should be communicated to us by client in advance, so that rework or repairing work can be eliminated.



EXHAUST HOOD



 For Exhaust, Fresh Air & Duct installation, Scaffolding, Ladders, or any "Core Cut" required will be in client scope.

- Any kind of D.O.L Starter or any other kind of Starters or switch will be supplied by Client as required.
- Labors for Shifting of heavy material like blower will be in client scope.
- If blower is located at terrace, then client must provide crane or hydra for lifting & placement of material.
- Electrical wire connection for blower from starter switches to blower machines will be in client's scope. (Electrical contractor from client side)
- If any support is required for hanging hood at ceiling, then arrangement for support will be in client scope.
- Filters/ oil collection tray will be available with Hood as standard accessories.
- In case of supply of Hoods, it includes only supply scope from our side. Hood installation from ceiling, collar & damper will be in client's HVAC contractor.
- Any kind of fabricated structure/ civil work required for mounting blower will be in client scope.
- Removal of false ceiling if already in place before erection of hood will be client scope.
- Responsibility of damage by fire suppression team will be in client's scope.

COLD ROOM

ELECTRICAL

- Provision of 220V / 1 Phase / 50Hz or 400V / 3Phase / 50 Hz supply ending in suitable MCB near the condensing unit.
- b. Provision of Stabilized Voltage Supply (Provide stabilizer if power fluctuation).
- c. Provision of platform / foundation for cold rooms and MS Frame/ Civil Platform for condensing units.
- d. Extra Accessories required i.e., MCB, Sockets, earthing plate, etc.

WATER & DRAIN

- a. Provision of drain traps [floor & wall] at points to be done as instructed by Janshakti team.
- b. Extra Accessories required i.e., Drain Trap, Drain piping, etc.

CIVIL & MASONRY WORK

- a. Structural works, Foundation / Shades for equipment at site, Proper PCC Base flooring for panel installation, it should be with 0-0 levelled.
