DEED OF PARTNERSHIP

This Deed of Partnership is made at Margao , Goa , on 8th of March 2019 .

BETWEEN

1. **Mr. ANIL KUMAR TEJAPPA RATHOD**, son of Mr. Tejappa R. Rathod , Indian National, major in age , having Pan No-BWFPR6463Q, Aadhar Card No-5461807183 , resident of – H.No.200/6B, Per Seraulim , Colva , South Goa , Goa, 403708. which expression shall mean and include her heirs, successors ,legal representative and assigns)hereinafter called **FIRST PARTY**

2. **Mr. TEJAPPA RAMAPPA RATHOD** ,S/o Mr. Ramappa Rathod , major in age , married ,Indian National , Pan NO- BGMPR3200G,Aadhar Card No- 382957723020, r/o- H. No. 200/6B, Per Seraulim , Colva , South Goa , Goa, 403708,(which expression shall mean and include her heirs, successors ,legal representative and assigns)hereinafter called **SECOND PARTY**.

WHEREAS the parties hereto are father and son , and have mutually agreed to start a business of partnership mainly to start a business of selling of Sea Foods items .

WHEREAS both the parties have full trust and mutual understanding in each other so as to form and constitute a partnership firm and

AND WHEREAS the parties are desirous of reducing the terms and conditions upon which they have agreed to carry on the said business in partnership.

NOW THIS INDENTURE WITNESSETH as follows .

1. The Name and the style of the firm of partnership firm shall be " **ANIL SEA FOODS** ".

The Principal place of business shall be at H. No. 200/6B, Per Seraulim , Colva , South Goa , Goa, 403708.

3. The duration of the partnership shall be "AT WILL" and shall continue until determined or dissolved by mutual agreement .
4. Both the parties mutually have decided to invest Rs. 1,60,000/- as investment amount to start the said business.
5. It is agreed between the parties that , said "Anil Sea Foods " business shall be run and manage by first party Mr. Anil Kumar Rathod.
6. That a banking account of the partnership firm shall be opened immediately, on commencement of this partnership firm in a mutually agreed nationalized bank, in the name of the partnership firm and it would be operated by first party Mr. Anil Kumar Rathod.
7. All the sums received by the firm whether in cash or through cheques or otherwise shall be deposited in bank.
8. The shares of the partners in the profits and losses ,if any , shall be as under-
 1. Mr. Anil Kumar Tejappa Rathod 80%
 2. Mr. Tejappa Ramappa Rathod 20%
9. The First accounting year of the firm shall end on the 31st day of March 2020 and on the 31 day of March every year thereafter .The partners may change the accounting year ,if necessary , expedient or convenient or if required The regular books of accounts of business of the partnership shall be maintained by the partnership wherein shall be made all the entries pertaining to all the daily sales , affects etc .

10. Each partner shall pay his separate debts punctually and indemnify the other partners and the capital.

11. The partnership have resolved that in the event of any necessity to change the terms and conditions of quantum relating payment of enumeration to partners or interest on capital to partners, which may be effected by way of execution of addendum to this deed of partnership.

12. Any partner shall retire from the firm after giving the other partners not less than three months notice in writing.

13. Every partner shall attend diligently to the business from the firm and carry it on to the greatest advantage of the partner; If one of the party dies then partnership shall be continue with new partner who will be a family member or any other party.

14. No partner shall without the written consent of the other partner do any of the following things :

a. Employ any of the moneys, goods, or effects of the partnership or pledge credit thereof or give any security or promise for the payment of any money on account of the partnership except in the ordinary course of business and upon the account and for the benefit of the partnership.

b. Assign, mortgage or charge his share in the partnership or any part thereof or make any other person a partner with her therein.

That the partnership shall be deemed to be continuing on the admission of a fresh partner or partners provided the admission is on the terms herein laid down and is approved by both the partners .

7. Any partner committing breach of any of the foregoing stipulations shall indemnify the firm and the other partners from all losses and costs on account thereof.

ACH PARTNER SHALL

A. Be just and faithful to the other in all transactions relating to the partnership.

B. At all times give to the others a just and faithful account of the same and upon every reasonable request furnish a full and correct explanation thereof to the other.

18. The First accounting year of the firm shall end on the 31st day of March 2020 ,and on the 31 day of March every year thereafter .The partners may change the accounting year ,if necessary , expedient or convenient or if required /permitted by law.

19. The regular books of accounts of business of the partnership shall be maintained by the partnership wherein shall be made all the entries pertaining to all the daily sales , affects etc .

20. That during the continuance of the partnership a general account shall be taken up to 31 st of March of every year, debts and liabilities of the partnership and every such annual general account shall be entered into books and shall be signed in such books by both the parties. As soon as the preparation of the profit and loss account and other formalities done the parties distribute their respective share of profit at the end of accounting year.

21. Each partner authorizes the others to act on behalf of the firm and every act done by a Partner in the ordinary course of business and shall bind the other

24. The partners may by mutual consent change, modify, alter, add or delete any of the terms and conditions specified therein.

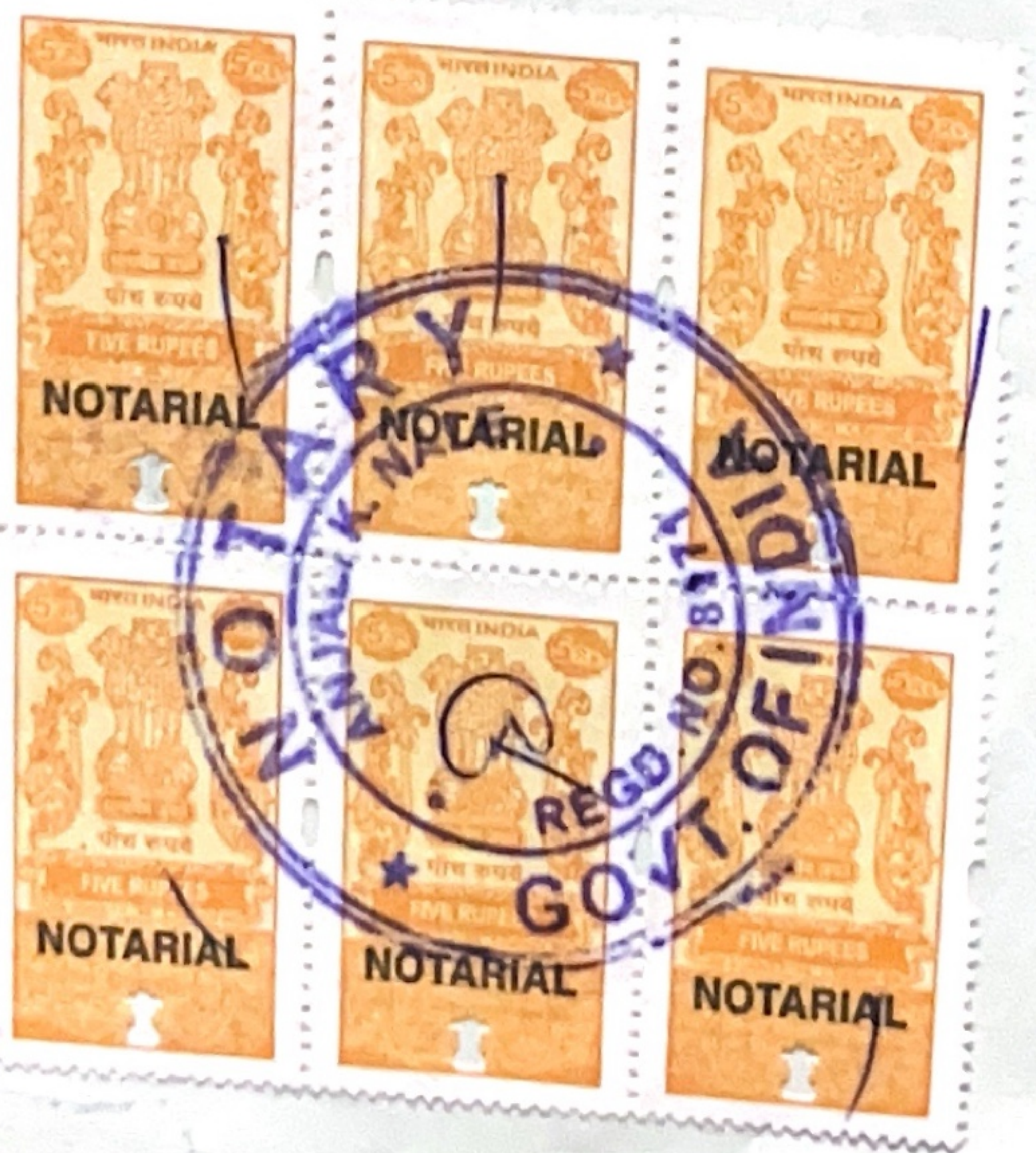

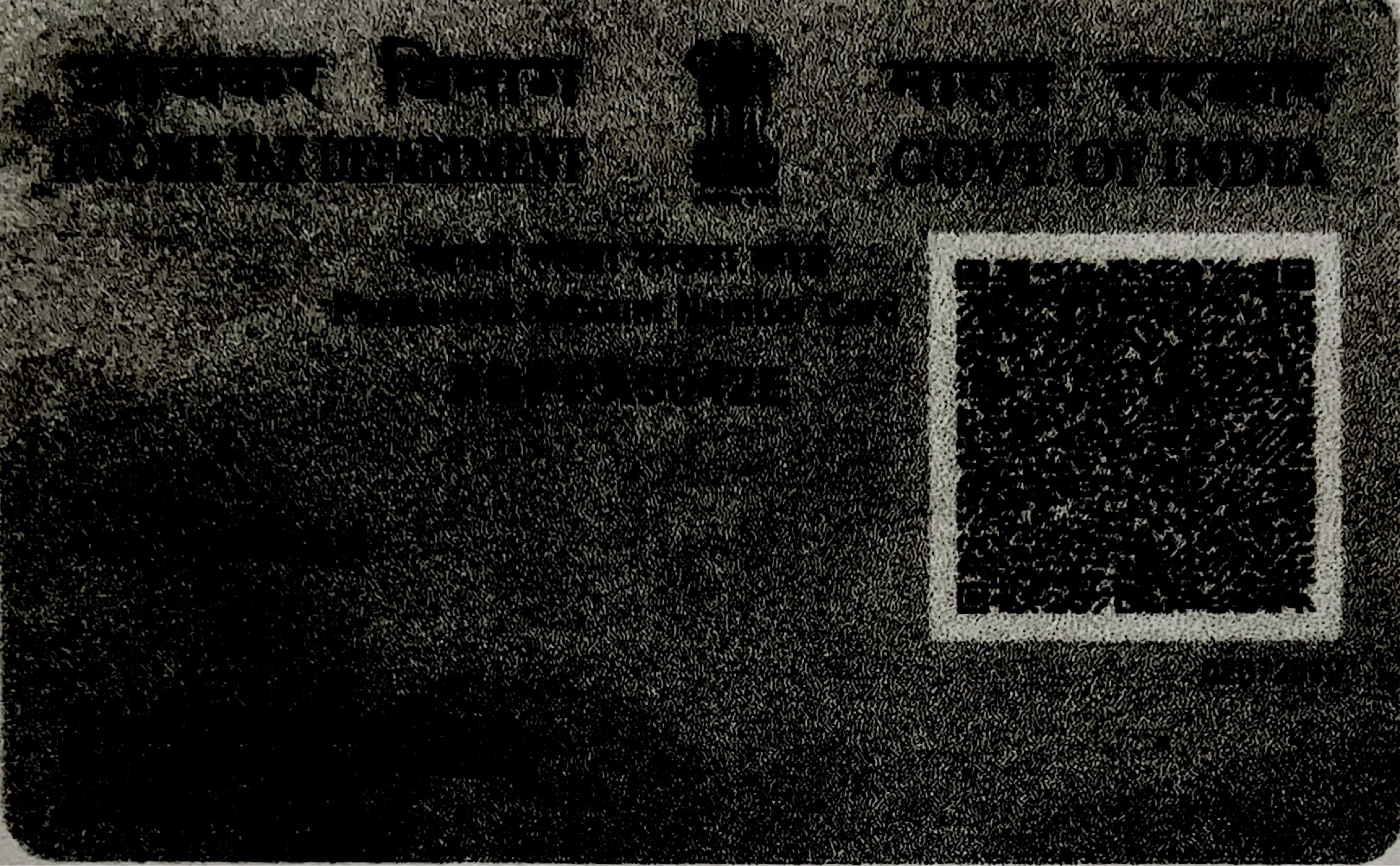
