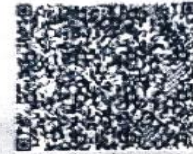

- Permanent Account Number (PAN) facilitate Income Tax Department linking all various documents, including payment of taxes, assessment, demand tax orders, matching of information and tax maintenance & return filing, etc. for better information sharing and processing of tax returns. स्थायी लेखा संख्या (पीएन) एक कार्ड है जिसमें विभिन्न प्रकार के डॉक्यूमेंट्स को जोड़ने में सहायता करने के लिए एक आसानी से पहचान योग्य और विश्वसनीय और प्रमाणीकृत जानकारी का आसानी से सत्यापन या सत्यापन करने के लिए प्रदान किया जाता है।
- Quoting of PAN is now mandatory for several transactions specified under Section 139A (1)(b) (Other Rules) of Income Tax Act, 1961 and Section 139A (1)(c) of Income Tax Act, 1961. It is also mandatory for several transactions specified under Section 139A (1)(b) and Section 139A (1)(c) of Income Tax Act, 1961. PAN का उद्धरण अब अनिवार्य है।
- Possessing or using more than one PAN is against the law & may attract penalty of upto Rs. 10,000. एक से अधिक स्थायी लेखा संख्या (पीएन) का प्रयोग या उपयोग करना, कानून के विरुद्ध है और इससे ₹10,000 तक का जुर्माना हो सकता है।
- The PAN Card enclosed contains Enhanced QR Code which is readable by a specific Assured Mobile App. Keyword to search this specific Mobile App on Google Play Store is "Enhanced QR Code Reader for PAN Card" and the keyword to search this specific Assured Mobile App on Google Play Store is "Enhanced QR Code Reader for PAN Card".



Electronically issued and Digitally signed ePAN is a valid mode of issue of Permanent Account Number (PAN) post amendments in clause (c) in the Explanation occurring after sub-section (8) of Section 139A of Income Tax Act, 1961 and sub-rule (6) of Rule 114 of the Income Tax Rules, 1962.
