I have to inform that Under Sec. 1 (3) of the ESI Act, the Central Government has made provisions of the Act applicable to all factories situated within the notified area.

2. आपको आगे सूचित करना है कि उपयुक्त सरकार ने अपनी दिनांक 18-9-78 की अधिसूचना संख्या क. रा. बी. - 1677/3910/पी. एच-14 के द्वारा दिनांक 12-11-1978 से कर्मचारी राज्य बीमा अधिनियम की धारा 1(5) के अन्तर्गत अन्य स्थापनाओं में भी अधिनियम के उपबंधों को बढ़ा दिया है ।

2. I have further to inform you that the appropriate Government has extended the provisions of the Act to other Establishments Under Sec. 1 (5) of the ESI Act with effect from 12-11-1978 vide notification No. ESI-1677/3910/PH-15 dated 18-9-1978, and to Road Motor Transport Establishments with effect from 13-3-1989 vide Notification No. ESI/2788/2999/CR/350/MED/13 dated 10-3-1989.

3. Under Section 2-A of the Act such a factory/establishment is required to register itself under the Act and Chapter IV thereof casts a responsibility on the Principal Employer thereof to insure its employees and to pay contributions in respect of


